## Concessions Report:

Bingo Report:

Anne Wellman reported that this past Saturday's session was good, it was Thanksgiving weekend. There are 3 sessions left before the end of the quarter and year. This will be a light quarter with approximately $\$ 16 \mathrm{k}$ in profits. The process continues as we transition Anne Wellman out and Shannon Longan in as the primary Bingo Manager for the club.

General Discussions:
A. Joe Johnson and Elizabeth Davies, both assistant coaches for Girls Basketball, requested use of the concession stand soda fountain for their annual Santiago's fundraiser dinner, which is to be held the next evening. Unfortunately, since the team is only giving the club 1 days notice, and two of the five fountain syrup boxes are very low, the club must decline the use of the soda fountain. Instead a donation of 100 cans/bottles of soda and bottled water will be given to the team.
B. Marty Duey made a short presentation of the brick paver project the club is planning for the main entry way of the new high school building. Meeting attendees were shown conceptual drawings of the design and shown colored pictures of some brick samples. Marty was asked to possibly get some actual brick samples so that a final selection on brick color can be made. This project will be a work in progress for many years to come and is also expandable once all bricks are sold within the original design. Marty was given approval to proceed as necessary.

## After Prom:

The After Prom committee will begin meeting regularly after the first of the year. Until then, there were a couple of items that needed handling:
A. The photo booth has been purchased, a firm date needs be reserved.
B. A quote will be requested for a magician/balloon clown.
C. Amy Schiers will summarize expenses from the past year so we can stay in line with our target budget.
