## NEW BUSINESS:

The only new business listed on this evening's agenda was the review and eventual vote for the new club bylaws. In-depth discussion was had by all in attendance in an effort to locate all important portions of the new bylaws. Corrections are as follows:

1. Section 5.03 - Dues: was corrected to reflect current amounts.
2. Section 3.01 - Articles of Organization: was corrected to include Articles of Incorporation.
3. Section 12.04 - Concessions: additional category E. was added to accommodate additional concession opportunities that may arise from time to time.

Member Denise Erickson requested that the bylaw vote should be tabled to the next meeting so that time would be available for bylaw review. Secretary Alison Vincent stated that the draft bylaws had been posted on the website for 1 week and an email had been sent to all current active members informing them of such posting.

Member Denise Erickson requested that Section 16.02 - Interactions of the Club - should be changed to Parliament and should include Roberts Rules of Order. The Officers of the Board stated that they were not comfortable committing to adhere to any document of this nature, and it would be unpractical to expect a volunteer who has no legal education to read this document.

## AFTER PROM UPDATE:

Committee Chairperson stated that things were moving along quickly but seem to be going well.

There was an upcoming fundraiser discussion - ARC Donation Truck - that will be conducted the weekend of January 18 \& 19. Nice, color flyers were available to anyone able to distribute within the Tri-Town area. Additional flyers will be available to many during the next few days as more are printed. The flyers will be sent electronically and in paper form to all local elementary schools and possibly in the grocery stores.

There was a lengthy discussion about the necessity to get approval from the SVVSD Risk Management Department before any deposit checks are written for After Prom activities. The Board of Officers expressed their concern about having laser tag within the school building and the current policy of the school district in relation to weapons and guns. It was agreed that the committee would be pro-active in their discussions with Risk Management to make sure and not place the Club in a position of liability.

The committee requested a deposit check for multiple items, however, since Treasurer Kristina Morganti was not in attendance, that would be a matter that would be followed up on in a couple of days. The hypnotist is the most important of these deposits as he is not confirmed for
the event until a deposit is placed. Alison Vincent will try to give the committee a specific dollar amount that has been earmarked for the event as soon as she is able to look through the financial documents of the club when the treasurer returns from her trip.
